# GUIDELINES FOR FILLING IN THE APPLICATION

- 1. YOUR APPLICATION: YOU MUST HAND IN
- a) The completed visa application dated and signed.
- b) **Original passport** with at least two opposing unused pages, valid for at least 6 months after scheduled departure from Mongolia. Your passport photo should look the way you look today.
- c) One original photo 3.5 x 4.5 cm taken less than 6 months ago.
- d) A copy of your **ticket** to / from Mongolia must be attached.
- e) A copy of your **hotel booking** or **tourist program** must be attached.
- f) **Prepayment** to the Consulate's bank account (see bottom of page), or **cash payment** upon delivery of the application. Please note that the Consulate cannot accept payment by credit card. g) When prepayment has been made to the account, a **copy of the payment must be enclosed**.

Please note that your application will **not** be processed if inadequately filled in, if an attachment is missing, or if payment is not made. If your application is denied, the fee will be refunded.

# 2. DELIVERY / RETRIEVAL

Your application must be handed in to KinaReiser AS, Hegdehaugsveien 10, Oslo, during the Consulate's opening hours (see our webpage for details). In winter the Consulate is only open on Tuesdays; while in summer it is open on Tuesday, Wednesday and Thursday. The application may be delivered and your passport picked up by someone other than yourself.

The Consulate **does not** accept an application or return a passport by mail.

# 3. TYPE OF VISA

The Consulate normally issues the following types of visa:

- I) **Single entry visa** allowing 30 days stay in Mongolia, valid for 90 days from issuing.
- II) **Double entry visa** allowing 30 days stay twice, valid for 90 days from the date of issue.
- III) **Single / double transit visa** which allows for 1 or 2 transit journeys through the country (without stopping), valid for 90 days.
- IV) **Multiple visas.** These visas allow for multiple entries and are issued with either 183 or 365 days of validity, but only after prior approval from the immigration authorities.

#### 4. OTHER VISA CATEGORIES

The Consulate has the authority to issue a regular entry visa and transit visa without prior approval from the immigration authorities. But if you plan to work, study, attend a conference etc., your contact in Mongolia must apply on your behalf in advance. This process can be time consuming, so you should get your contact to apply for your visa in good time before your scheduled arrival. We emphasize that you do **not** have permission to work or study with only a regular / tourist visa.

# 5. PROCESSING TIME

The normal processing time is one week. Express visa can be obtained within 8 hours, against double fee.

#### 6. CHARGE

A fee is payable per visa application. If several people apply at the same time and shall have the same program in Mongolia, a discount will be given per application. The visa fee is:

A former Mongolian citizen who has taken Norwegian citizenship will only pay NOK 300. Norwegian children under 16 years of age with a Mongolian parent will only pay NOK 300 if the parent has retained his/her Mongolian citizen-ship. The parent's passport must be presented.

# 7. REGISTRATION / EXTENSION

If one wish to work or study in Mongolia, and the stay will exceed 30 days, one must register with the immigration authorities within 7 days of arrival (address: see the application form, paragraph 25). That same office in Ulaanbaatar has also the authority to extend an ordinary 30 days entry visa. This request should be made as early as possible before your visa expires, preferably at least one week in advance. Such extension may be granted once every half year.
